Functions and Responsibilities

The functions and responsibilities of the committee include:

- 4 Recommending actions to the Principal based on findings.

Term of Tenure

Members of the Anti-SC/ST Harassment Committee will serve for one academic year, with the possibility of reappointment.

Meetings

The committee will meet monthly during the academic year and as needed for urgent matters.

Quorum Requirement

A quorum will be established with at least three members, including the Chairperson or their delegate.

Confidentiality

The committee will ensure that all grievances and investigations are handled with strict confidentiality.

The committee's constitution will be reviewed annually to ensure its effectiveness. Amendments to the constitution require a two-thirds majority vote from committee members and final approval by the Principal.
